This is a full time, permanent position with the Kenai Watershed Forum. This position is the lead project manager for the organization's Invasive Species eradication and management program. This position may be funded by various public and private sources through grants, donations and contracts. The person responsible for this position will be expected to manage the current grants that now fund the program but also manage their time to be able to research and generate grants for successive year's operations. This position will be expected to produce reports for each respective project, tabulating and summarizing each project's results. Public presentations on the projects and program are to be expected. Preparing each project after conclusion for web presentation may also be expected.

The program presently has two primary foci: Reed Canarygrass (RCG) management and Elodea eradication. This position collaborates with other partnering agencies and organizations throughout the Kenai Peninsula in addressing invasive species within the many watersheds of the Kenai Peninsula Borough. This position will coordinate work with contractors, staff, volunteers and associated agencies.

Applicants should be able to demonstrate an ability to perform common plant identification endemic to the Kenai Peninsula, particularly aquatic plants.

The person selected for this position should be proficient in working with most basic computer software (MS Office Suite).

Qualifications

- A four-year degree in Life or Physical Sciences is required, a Master's degree is preferred
- At least one year in field data collection experience
- Demonstrated experience in organizational, managerial, and communication skills
- Have a demonstrated knowledge of the Kenai Watershed Forum mission, history, performance and role in the community.

Other duties include:

- Prioritize affected sites and specific actions. Take part in assessment of potentially infected lakes and streams and organize and participate in detection and response measures when possible.
- Schedule all field work/sampling, people and equipment.

- Coordinate invasive management efforts with partners and granting agencies
