## Assessing Flood Damage from a Kayak

This January, the Kenai River experienced its largest winter flood in many years. A few days after the peak of the flood, Robert Ruffner asked me if I'd be interested in kayaking the river with him. We both were interested in surveying the damage; he would view it through the eyes of a trained observer, while I would just look in awe at the aftermath of what had happened the week before.

Saturday, February 3 dawned clear and cold, and we were off. The plan was to put in at Swiftwater Park in Soldotna, and take out at Slikok Creek near Kenai Peninsula College. We drove a couple of miles upriver to put in at the Agrium boat ramp. This way we had the opportunity to view even more of the damage. We paddled for approximately three hours, and covered about seven river miles.

Floating the river gave us a unique perspective on what damage might have been done. It was an incredible trip. The sky was electric blue above the brilliant white ice. In some places we felt like we were traveling through a tunnel, with the ice jams on both sides of the river tow-

ering ten to twenty feet over our heads. Many of the walkways that were at or below flood level were still encased in ice, and probably will be until well after breakup. Those that we could see had become twisted metal and splintered wood. Trees and vegetation were bent, broken, and twisted as well. We were able to talk with some property owners

### Caring for the Kenai

Caring for the Kenai (CFK) is an environmental contest that challenges local high school students to tackle a local environmental or natural disaster preparedness issue. This contest has been around for over 17 years and has touched generations of students on the Kenai Peninsula. The title sponsors are Agrium and Chevron.



Beginning in 2003, Kenai Watershed Forum became the Contest Administrator and began managing all financial aspects of the contest. Since then, our involvement has expanded and we now help with CFK website development and management, the judging process, marketing, and the Semi-Finalist Awards Program, among other things. We believe it is a worthwhile educational tool and fits into our mission well. We are working hard to bring our expertise to the contest with the hopes of continuing to raise the quality of entries.

This year's contest is in the judging phase - the nearly 440 entries have been narrowed down to 12 finalists. The top 12 contestants will present their projects at the Oral Presentation on April 19 at the Kenai Little Theatre.

Jessica taught middle school science in Central Oregon. While teaching, she was instrumental in the local "Fish Fest", which is very similar to our Kenai River Festival. In addition to starting a student greenhouse for propagating willows. Jessica worked with her students on riparian restoration projects on local ranches in cooperation with the Crooked River Ecosystem Education Council and with much help from Oregon Fish and Game.

Then, five years ago Jessica returned to the Soldotna/Kenai area and became a full-time mom. She has elected not to return to the work force and now is the mother of two. Jessica says, "I have missed interacting with students and contributing to environmental issues. I am extremely happy to be aboard the Kenai Watershed Forum as I see it as something that both enables me to contribute to our community and also gives me opportunity to implement my skills & interests."

#### Howard Ferren

Howard currently resides in Seward and serves as the Assistant Director for Research Operations at the Alaska SeaLife Center (ASLC). Howard also serves as Principal Investigator and Co-Investigator on salmon and herring restoration grant awards received by ASLC through the Southeast Sustainable Salmon Fund and EVOS Trustee Council.

Howard moved to Alaska in 1974 to attend graduate school at the Institute of Marine Science, UAF, and resided in Fairbanks for 15 years before moving to Cordova where he served Prince William Sound Aquaculture Corporation as Planner to the Regional Planning Team for Salmon Enhancement, and


later as VP Administration and Interim CEO. In 1997 he and his wife Dyan moved to Oregon and later, South Carolina, serving two different businesses shouldering Chief Operating Officer and President responsibilities. Missing the snow and adventures of the Far North, he and his wife returned to Alaska in 2002. Leveraging his responsibilities as PI on salmon enhancement and restoration grants, coupled with the ASLC mission, Howard believes he can contribute to the Kenai Watershed Forum and help represent KWF to residents of eastern Kenai Peninsula.

Kristy McCullough
Kristy moved to Anchorage after obtaining a chemistry degree from Louisiana State in 1997 - she was out to see the world and never looked back. Her first few years in Alaska were spent in Environmental and Production Labs in both Anchorage and Prudhoe Bay, where she learned the procedures behind numerous environmental sampling and analysis techniques. Kristy was a member of the Anchorage Waterways Council, and when she moved to Soldotna with her husband in 2002, she joined the Kenai Watershed Forum and began helping with monthly monitoring of the Killey River.

Presently Kristy is head of the Environmental department at Agrium. In addition she and her husband operate a small lodge on the river where he's our fishing guide. As a new board member, Kristy says, "I'm still trying to learn HOW I can be the most help. I'm a scientist to the very core, so I'd love to help KWF perform studies on observable effects to the Kenai Peninsula from controllable sources. It's important to show communities how they can individually make a difference in directing the change happening in their environment."

and residents who were out trying to determine how much damage they had suffered.

There were some encouraging signs, at least to my untrained eye. Only one short section of bank was denuded of vegetation. We saw only two pieces of debris in the river (one just upriver from the bridge, and one just upriver of the sonar location at Slikok). There was some irony at that site as well: the sign on the small structure there reads THIS ELEVATED LIGHT PENETRATING WALKWAY IS INTENDED TO PREVENT DAMAGE TO STREAMBANK VEGETATION. The vegetation was in good shape while the walkway was unrecognizable.

The City of Soldotna and the Kenai Peninsula Borough have issued disaster declarations. Private property owners and public entities have spent millions of dollars to provide access to the Kenai River, as well as to protect habitat. Rebuilding and restoration need to be done, but we need to keep one crucial concept in mind. Flood events have happened before, regardless of the season of the year. They will happen again. All of us will need to keep this in mind as we strive to preserve and protect the Kenai River for future generations.



#### What Caused this Flooding Event?

The Skilak Glacier Dammed Lake is located in the Harding Ice Field above the Skilak River. This lake is smaller than the Snow Glacier dammed lake, and releases typically cause a 1-4 foot rise in the Kenai River below Skilak Lake. The lake began releasing around the 16th of January 2007 and the Kenai River at Skilak Lake rose about 3.8 feet since the 18th. The Kenai River below Skilak Lake experienced a broad crest on the 27th. The rise in water levels caused the ice cover to break up and form ice jams and localized flooding in the Soldotna vicinity. Rapid water level increases and moving ice caused significant property damage. The lake typically releases in the late fall every two years. It was due for its current release. ## Crooked Creek Restoration and Education Project

As an extension of the Adopt-A-Stream program with Kelly Balise's Tustumena Elementary 6th Graders, KWF is working with a partnership of local students, teachers, parents, local community volunteers, and natural resource organization and agency personnel to begin the 2-year Crooked Creek Restoration and Education Project. Partners will work to stabilize the stream bank, create a study area for Adopt-A-Stream students, build habitat protection and handicap accessible viewing and fishing platforms and install walkways and educational signs. These partners will work to restore this critical habitat and create a model conservation, education, and fishing area for youth, local residents, and visitors.

With over 61 miles of riparian habitat, Crooked Creek is one of the longest anadromous streams on the Kenai Peninsula and is home to strong runs of chinook and coho salmon and steelhead. This section of Crooked Creek is a very popular community use area because it is one of the few public access areas for spawning chinook salmon viewing on the Kenai Peninsula. Local community members and visitors are seen in significant numbers in this area every year. After August 1st, it is also a heavily used fishing area. As a result, the stream bank has and continues to show a significant impact. This impact has been dramatically increased by the failure of a culvert road crossing during the flood of 2002, which caused a small viewing platform and stream stabilization structures to be lost.

Tustumena Elementary students, teachers and parents are currently involved in project planning--such as photographing public use and impacts to the creek, designing educational signs, and researching platforms, walkways, and habitat

restoration techniques. KWF will coordinate a "Stream Team" of youth, parents, community members and resource professionals to complete a creek clean-up, stream bank restoration projects, educational sign installation and study and viewing platform construction on the banks of Crooked Creek.

Funding for the 2-year Crooked Creek project has been secured from ConocoPhillips Alaska and the National Fish and Wildlife Foundation More Fish Fund. Additional funding is required for the construction of a foot/ATV bridge.
